

SECTION SEVEN
TANO NORTH MUNICIPAL ASSEMBLY
(PUSH TRUCK) – BYE-LAWS, 2018

- Act 936: In exercise of the powers conferred on the Tano North Municipal Assembly by section 181 of the Local Governance Act, 2016 (Act 936) the following Bye-laws are hereby Made:
- Title: 1. These Bye-laws may be cited as the Tano North Municipal Assembly (Push Truck) bye-laws 2018 and shall apply within the area of authority of the Tano North Municipal Assembly (hereinafter referred to as the “Assembly”)
- Licence 2 (a) Every owner or person in possession of any vehicle having wheels not propelled by mechanical power in use for the carriage of goods within the area of authority of the Tano North Municipal Assembly (hereinafter referred to as the Assembly) shall obtain a Licence for such vehicle.
- (b) Every Licence issued under these Bye-laws shall expire after 12months from the date of issue
- Fee: 3. There shall be payable for any such Licence a fee fixed by a resolution of the Assembly
- Exhibition of Number plates/Sticker: 4. Every vehicle for which a Licence is issued shall have affixed thereon a sticker of the Assembly.
- Condition: 5. No Licence shall be issued under paragraph (1) in respect of a vehicle, which in the opinion of the Assembly is in such a condition as to endanger persons or property
- Persons below 18 years not eligible 6. No person below the age of 18 years shall push any vehicle Licenced under these bye-laws.
- User to observe road traffic regulations: 7. (a) Every user of any vehicle Licenced under these Bye-laws shall observe normal rules of the road and shall keep close to the right-hand side of the road.
- (b) No vehicle Licenced under these Bye-laws shall operate before the hours of 5:30 in the morning and after 10:00 in the evening.
- (c) No user of such vehicle shall sit on it while it is in motion
- Offence: 8. Any person who contravenes any provision of these Bye-laws commits an offence and on summary conviction shall be liable to a fine not less than **One Hundred (100) Penalty Units and not exceeding Two Hundred and Fifty (250) Penalty Units or in default of payment to a term of imprisonment not below Six(6) months and not exceeding Twelve (12) months or to both the fine and imprisonment**

Application: 9. These Bye-laws shall apply within the areas of authority of the Assembly
